- Propagating credential information of an employee from one PACS to others, thus supporting enhanced access control at multiple facilities.
- Easy revoking of physical access privileges across multiple PACS.

Find out how the PLAI specification offers a standardized, automatic way to solve one of enterprise security's most stubborn challenges, that of synchronizing logical and physical identities and their access privileges. The PLAI specification is yet another way the PSIA is driving open standards use into access control and throughout the security ecosystem.
